## **2009 DSC RIDER PROGRAM DETAILS**

*The ownership and management of Delano Sports Center wish to welcome you to our race sponsorship program. Our hope for you is to have a safe and successful season racing. DSC has established new guideline that will be followed in order to obtain or retain all programs listed. Any misrepresentation of DSC in anyway, on or off the track, will result in immediate termination from any racer program for the 2009 season. With your help we can continue to make our program more comprehensive and beneficial for all parties involved.*

- 1. Rider to display DSC logo prominently on both sides of bike and or hauler. DSC will provide 1 set of "DSC" side shroud graphics kit (per bike purchase) with standard (dealer) sponsor logo's added at no charge to each rider on the race program. DSC fender stickers will be provided at no charge throughout the season. All other stickers and or additions or variations needed per contract agreement are sole responsibility of rider to obtain and display on all bikes and equipment throughout the season.*
- 2. Bio information, including photographs, results per event attended, and all other information requested by DSC, is to be provided on a weekly basis, or no later than 1 week past the last event the rider participated in.*
- 3. When rider attends any and all events, they include all sponsor information on signup sheets listing DSC as the first and title sponsor of that event. Rider will mention DSC in all editorial interviews and especially during any podium interviews.*
- 4. Rider agrees to work or attend at least 1 open house per year that DSC promotes. That may include but is not limited to displaying of riders bikes, trailers, and other propaganda DSC provides you with for that function.*
- 5. All parts purchased/ordered must be for the sole use of the rider or their machines only.*
- 6. Oil program will consist of ordering bulk quantity at any given time at employee pricing.*
- 7. Tires can be purchased throughout the season on demand at employee pricing.*
- 8. All other programs that DSC incorporates or provides will follow same guidelines as listed on this or previous contract pages.*
- 9. Riders are entitled to 1 free DSC hat or t-shirt per year. Additional t-shirts or hats can be purchased at our cost.*
- 10. Riders will use, promote and endorse DSC as there dealer. Rider will not list or promote any other "motorsports dealer" as long as they are on the DSC sponsor program.*
